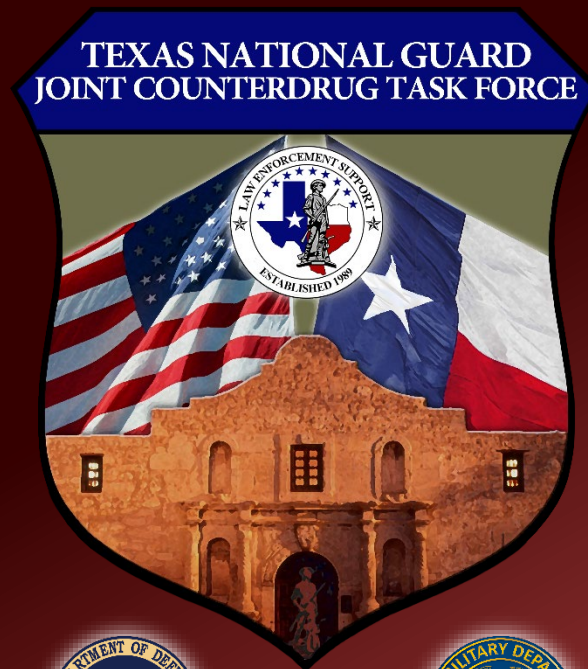
## Additional Program Support Capabilities

## LOGIC MODEL

A visual tool that addresses root causes of drug-related issues and develops short and long-term goals and strategies.



## TECHNICAL ASSISTANCE

Training for coalitions on various subjects including, but not limited to, mission and vision statements, welcome packets, capacity building, sustainability and cultural competency.



## LAW ENFORCEMENT

Access to law enforcement resources and capabilities.



## DDR Outreach Mission

Through support of the High Intensity Drug Trafficking Areas (HIDTA) and other federal, state, and local law enforcement agencies and partners, the Texas National Guard Joint Counterdrug Task Force Drug Demand Reduction Outreach program provides militarily unique skills bringing innovations to address the ever-growing threat of substance abuse and misuse facing Texas communities, including the growing fentanyl crisis. This is accomplished through science-based prevention and education training, leveraging community partners, and networking resources from the national down to the local level in order to effect a positive change in communities

## Strategic Prevention Framework

A 5-step planning process that guides community-based organizations in the selection, implementation and evaluation of effective, culturally appropriate and sustainable prevention activities.

**ASSESSMENT:** Understand community and historical perspectives, analyze data and identify trends.

**CAPACITY:** Define and build resources and readiness.

**PLANNING:** Propose strategies and devise actions to be taken.

**IMPLEMENTATION:** Carry out processes necessary to completing the plan.

**EVALUATION:** Assess effectiveness of outcomes.
