Summary. This regulation describes the office symbols approved for Texas State Guard force usage down to the battalion level.

Applicability. This regulation applies to the Texas State Guard.

Management control process. This regulation contains management control provisions for assigned office symbols, office symbol use, office symbol formatting, and addressing system guidance for correspondence.

Proponent and exception authority. The T1, TXSG is the proponent for this regulation and has the authority to recommend exceptions consistent with the controlling law and regulation, subject to the approval of the Commanding General, TXSG.

Supplementation. Supplementation of this regulation or establishment of brigade or local policies outside of the

authority dictated by this regulation is prohibited without prior approval from the Commanding General, TXSG, through the T1, TXSG available at mail: ATTN: NGTX- TPE, P.O. Box 5218, Austin, TX 78763-5218.

Suggested improvements. Users may send comments and suggest improvements on DA Form 2028 (Recommended Changes to Publications and Blank Forms) directly to T1, TXSG mail: ATTN: NGTX-TPE, P.O. Box 5218, Austin, TX 78763-5218.

Chapter 1 Introduction

Section I

General

1-1. Purpose

This regulation prescribes the use of office symbols throughout the Texas State Guard (TXSG) and prescribes TXSG Addresses and Office Symbols online database as the official website for office symbols.

Section II

Responsibilities

1-5. T1, Texas State Guard

The T1, TXSG will—

- a.* Serve as the senior TXSG policy official for the office symbols.
- b.* Review and approve office symbols for command headquarters and lower command levels as provided by the SGS, TXSG.

1-6. Secretary of the Commanding General's Staff, Texas State Guard

The SGS, TXSG will assist in the development of office symbols for command headquarters and lower command levels, and forward to the T1, TXSG for review and approval.

Chapter 2 Office Symbols

2-1. Overview

- a.* Use office symbols for:
 - (1) Identifying the originators of correspondence and electronically transmitted messages within the TXSG.
 - (2) Denoting the placement of an organization with the TXSG structure for historical and records purposes.
- b.* Changes to office symbols can only happen for the:
 - (1) Creation of new organizational elements.
 - (2) Termination of existing organizational elements.
 - (3) Merging or dividing organizational elements.
 - (4) Significant change to the name of an organizational element.
- c.* This regulation prohibits changing an office symbol due to the change of an activity's name.

2-2. Understanding Office Symbols

- a.* The first four letters of the office symbol, NGTX, represent the TMD.
- b.* Each TMD office and element has a designated office symbol represented in the first line of the NGTX office symbol address.

c. Office symbols must:

- (1) Follow the NGTX format prescribed in table XX.
- (2) Remain short and concise.
- (3) Not exceed ten characters.

2-3. Office Symbol Formatting

Construct TXSG NGTX symbols as follows:

a. The fifth letter character is the mandated component of TMD as follows:

- (1) NGTX-T = TXSG HQ.
- (2) NGTX-U = 1st Brigade.
- (3) NGTX-W = 2nd Brigade.
- (4) NGTX-X = 3rd Brigade.
- (5) NGTX-Y = 6th Brigade.
- (6) The letter “V” currently designates ARNG Recruiting and cannot be duplicated elsewhere in TMD office symbol construction.

b. The sixth letter character, K, represents all TXSG Battalions, and the seventh letter character represents the battalion level unit. For example:

- (1) NGTX-UKA = 1st Brigade, 1st Battalion.
- (2) NGTX-UKB = 1st Brigade, 2nd Battalion.
- (3) NGTX-UKC = 1st Brigade, 3rd Battalion.
- (4) NGTX-UKD = 1st Brigade, 4th Battalion.

c. The eighth and ninth characters each represent subsequent lower-level units such as a company, structured as follows: NGTX-UKA-A = 1st Brigade, 1st Battalion, Alpha Company.

Chapter 3

Using Office Symbols in Correspondence and Publications

3-1. Using Office Symbols in Correspondence

a. Correspondence procedures prescribed by AR 25-50, including the placement and positioning of addresses on correspondence and mail, also apply to addresses using NGTX office symbols.

b. Using wrong or obsolete office symbols cause rejected or undeliverable mail or correspondence.

c. For correspondence or mail within NGTX:

(1) The address' first line states the legacy office symbol and branch designation (and individual designation when appropriate): NGTX-AH/COL Ray.

(2) The address' second line states the on-post location, by building: Camp Mabry BLDG 32.

(3) The address' third line is blank.

d. For correspondence or mail to and from NGTX:

(1) The address' first line states: Adjutant General of Texas, but the format depends on where the destination of correspondence or mail.

(a) Abbreviate the first line to AGTX when sending correspondence or mail within the Adjutant General's Department.

(b) Spell out Adjutant General of Texas when sending correspondence or mail outside the Adjutant General's Department.

(2) The address' second line states the office symbol.

(a) If the memorandum goes to an individual's attention, after the office symbol add a forward slash followed by the recipient's rank and last name, then enclose in parentheses.

(b) Example: (NGTX-TPE/COL Ray).

(3) The address' third line states the Post Office Box address, for example: PO Box 5218.

(4) The address' fourth line states the City, State, Zip Code +4. For example: Austin, TX 78763-5218.

e. A complete address to and from NGTX looks like:

(1) Line 1: Adjutant General of Texas (or AGTX)

(2) Line 2: (NGTX-AH/COL Ray)

(3) Line 3: PO Box 5218

(4) Line 4: Austin, TX 78763-5218

3-2. Using Office Symbols in Publications

a. All NGTX publications effective the date of the publication and after must conform to the office symbols and addressing system prescribed within this regulation.

b. Current publications requiring amendment or revision must conform to the office symbols and addressing system prescribed within this regulation at the time of amendment or revision. Do not amend or revise a publication solely to update office symbols or addressing systems.
