**Summary.** This supplement requires eligible officers to meet the mandatory promotion board under the Reserve Officer Personnel Management Act (ROPMA) Texas Air National Guard (TXANG).

**Applicability.** This instruction applies to all officers of the TXANG.

**Management Control Process.** This instruction contains management control provisions. Compliance with this instruction is mandatory.

**Proponent and Exception Authority.** The proponent of this instruction is the A1 (NGTX-CDP). The A1 has the authority to approve exceptions to this instruction that are consistent with controlling law and regulation. Within the following pages, the "proponent" is the drafting authority of the instruction.

**Supplementation.** Supplementation of this publication or establishment of command and local forms is prohibited without prior approval from the Adjutant General (TAG), through the A1, ATTN: NGTX-CDP, P.O. Box 5218, Austin, TX 78763-5218.

## **Supplemental.**

Officers eligible to meet the mandatory promotion board under the Reserve Officer Personnel Management Act (ROPMA) who have not completed the appropriate level of Professional Military Education (PME) for the next higher grade will be considered not professionally qualified for promotion in accordance with AFI 36-2504. However, such action does not in itself make the officer ineligible for consideration. Therefore, officers selected for promotion by the mandatory promotion board who have not completed the appropriate level of PME may have their promotion involuntarily delayed until the Wing Commander, and the Commander, Texas Air National Guard determine the officer is professionally qualified to assume the higher grade. Failure to complete PME within the delayed period will result in separation from the Texas Air National Guard one day prior to the effective date of promotion.
