SUBJECT: Policy Memorandum #16, Officer Candidate School Admittance

1. References:

a. NGR 600-100 Commissioned Officers Federal Recognition and Related Personnel Actions.

b. Army National Guard Officer Candidate School Basic Officer Leader Course-A Course Management Plan (CMP), Version 11.

- 2. Purpose: Provide guidance for soldier's admittance into Officer Candidate School.
- 3. **Background**: The Officer Candidate School (OCS) is part of The Army School System (TASS), administered by the Army National Guard (ARNG) under authority of the Commanding General, US Army Infantry School (USAIS).

a. The OCS proponent requires that certain prerequisites be met for admittance into OCS.

b. Resource efficiency dictates attendees also meet commissioning requirements for admittance in order to minimize the training resources expended on candidates which are not eligible for commissioning in the Army National Guard.

4. Admittance Requirements: For admittance into OCS, soldiers will:

a. Work with their respective unit personnel, Officer Strength Management, and 2/136th Regional Training Institute to determine their eligibility for OCS.

b. Document that eligibility per the <u>OCS Student Enrollment Prerequisite Checklist</u>. (Attachment 1)

c. Submit their completed packet through Officer Strength Management for validation by the published deadline. (No applicant will be admitted into any phase of OCS without a completed and validated packet.) NGTX-SCC-Z SUBJECT: OCS Admittance Policy

c. Provide the timeline and actions the soldier will take to ensure the requirement will be met.

- d. State the benefit for the TX ARNG if the leniency is granted.
